Privacy Notice

The partners of the business partner acknowledge that the information provided by Exim Broker Trasnport S.C is confidential and for particular use in the development of projects, all information which comes to their knowledge, that is provided in connection with the activities they carry out, as well as information on the nature, characteristics and purposes of the services that Exim Broker Trasnport S.C and the business partner develop, design and market, the means or strategies for distributing or marketing products, information on costs, selling prices, accounting and tax information contained in financial statements, information relating to the results of business years, names and characteristics of customers and suppliers, all the systems and software used by Exim Broker Transport S.C, as well as projects, designs and technology.

The staff of the business partner also acknowledges that all such information is contained in documents, records, electronic or magnetic media, optical disks and other similar instruments; except for information, data, knowledge, etc., which are in the public domain.

The staff of the business partner is also aware and acknowledges that all confidential information mentioned above constitutes industrial and commercial secrets Exim Broker Trasnport S.C under Articles 82 and 83 of the Industrial Property Law.

The persons constituting the business of the business partner are aware of Article 82 of the Industrial Property Law which is considered an industrial secret, any industrial and commercial application information held in confidence by a natural or legal person, means obtaining or maintaining a competitive or economic advantage over third parties in the performance of economic activities and for which it has adopted sufficient means or systems to preserve its confidentiality and restricted access thereto.

The persons constituting the business of the trading partner are aware that Article 223 of the Industrial Property Act makes it an offence to disclose or seize industrial secrets, irrespective of the obligation to make good the damage caused. That as a result of the foregoing, both during the time that the staff perform their services and upon termination of the relationship with Exim Broker Trasnport S.C, it undertakes the following commitments:

- a) Not disclose or permit the disclosure to third parties of confidential information referred to above.
- b) Not to make or permit copies of items containing such confidential information.
- c) Not to use such confidential information for personal or third-party financial gain.
- d) Use such confidential information solely for the purposes of your position.
- e) Return immediately to Exim Broker Trasnport S.C, all documents, electronic or magnetic media or any other similar instrument containing confidential information and would have come to my power.
- f) Do not keep copies of the many confidential information.

Anti-corruption - Anti-bribery

Likewise commits and invites its members, customers, suppliers, business partners, collaborators and in general by all those who directly or indirectly have a relationship, either temporary or permanent with it, to report any act of corruption or bribery or influence peddling that may exist in connection with the provision of its services. The performance of any activity in contravention of this paragraph may constitute an offence subject to punishment by the appropriate authorities.
